Presentations and Proclamations:

Buffalo County Sheriff Department—Contract Law Enforcement Report: Sergeant Valenzuela reviewed the report. December was a pretty steady month. The CSO is working on parking violations. CSO Gary Davenport has retired. We are in the process of filling this position. Sara Diaz will take Gary's spot, and we will hire a new CSO.

WWTP Report and Water Report: There were no permit violations in December. We have been working on influent pump #2. The radar unit has stopped working at the WWTP influent. We changed over to our backup transducer. We are waiting for a technician to come out and look at the radar unit. We are cleaning the influent transducer weekly until we get the radar unit repaired. The backup generator jelled up. We had a natural gas leak at the water station. Black Hills repaired the leak on their meter. Water: After a software update we did have some issues getting some of the water meter equipment to communicate. Well #1 is back in service. We completed 9 locates. We have been doing extra sampling of the chloride levels. We have written a letter to the state requesting a change of the level amounts. We are right on the edge of making the permit levels.

Mayor Report: Received word that Jim Condon passed away. He was a member of Olsson Associates, our engineering firm. Barry Hemmerling our City Attorney had an accident this weekend and I would ask you to keep him in your prayers. We have received some street complaints concerning the snow removal. The rest of the items will be addressed later in the meeting.

City Attorney Report: No report. Attorney Hemmerling unable to attend the meeting.

City Administrator Report: I have been working with Darrin Robinson the past few months on a possible business coming to Gibbon. We Submitted 2 sites for the location of the business and they are very interested in the site located on Gibbon Road. It would be a fairly large building. We have been dealing with the snow events, cleaning the streets and repairing equipment.

City Treasurer Report—Tonniges & Associates: Unable to attend the meeting.

Shannon Slagle (Commander Gibbon American Legion Post 310) & Trevor Reeder (current owner of the Motor Inn, Shelton NE & soon to be owner of a new establishment in Gibbon) request revision of City's

Ordinance concerning hours of sale for beer and liquor Monday-Saturday and Sundays: Shannon and Trevor would like the City to consider extending the hours for the sale of liquor. Surrounding towns serve Mon-Sat till 1:00 a.m. and midnight on Sunday. The Mayor said she did not appreciate the comments made after the New Year's Eve incident. It was not the fault of the City because the establishments could not serve after 10:00 p.m. No one made a request to have it changed. We will act on an Ordinance concerning the hours for the sale of alcohol at the February Council Meeting. We will have the first reading at the February Meeting and the 2nd & 3rd reading at the March Council Meeting. Council Member Stall suggested setting the hours the same for every day.
