The Gibbon City Council, Buffalo County, Nebraska met in open public session at 6:00 p.m. at City Hall on Monday, October 21, 2019. Notice of the meeting was given in The Shelton Clipper on December 12, 2019 and by posting at Gibbon City Hall, Gibbon Post Office and Gibbon Exchange Bank.

Presentations and Proclamations:

Mayor Report—Deb VanMatre: The Mayor gave an update on the lottery status letting the council and those present know the ordinances to conduct a lottery, lottery sales outlet locations and who may participate had been passed last month. The next step is approving the Lottery Operator Agreement, initial sales outlet location and naming an authorized representative.

Mayor VanMatre let the council know that Susan Tonniges has been working on the treasurers reports and will have three months of reports at the January meeting. Much of her time has been spent in preparation for the audit, which was not completed properly by the previous treasurer.

The Mayor indicated her recommendation for the appointment of Bob Krier to fill the vacancy on the Council representing Ward 2.

City Administrator Report—Chris Rector: Chris let the Council know the status of the 5th Street water and sewer line project. He also indicated crews would be working at Borden's property on LaBarre to move an existing water line that was covered by an addition to the home many years ago. In addition, the auditors are here for the annual audit this week.

Buffalo County Sheriff Department—Contract Law Enforcement: Sargent Gibbs reported that Gibbon was fairly quiet last month with nothing significant to report. Todd Ochsner, the CSO, is anxious to return to work. Jon, the CSO who has been covering for Todd during his absence, is providing the contracted hours in Gibbon. There is also a Deputy Sheriff in town for at least fifteen hours a day.

Resolution # 2019-14—Signing of the Year-End Certification of the City Street Superintendent Form 2019

Whereas: State of Nebraska Statutes, sections 39-2302, and 39-2511 through 39-2515 details the requirements that must be met in order for a municipality to qualify for an annual Incentive Payment;

Whereas: The State of Nebraska Department of Transportation (NDOT) requires that each incorporated municipality must annually certify (by December 31st of each year) the appointment of the City Street Superintendent to the NDOT using the Year-End Certification of City Street Superintendent form;

Whereas: The NDOT requires that such certification shall also include a copy of the meeting minutes showing the appointment of the City Street Superintendent by their name as it appears on their License (if applicable), their License Number and Class of License (if applicable), and type of appointment, i.e., employed, contract (consultant, or interlocal agreement with another incorporated municipality and/or county), and the beginning date of the appointment; and

Whereas: The NDOT also requires that such Year-End Certification of City Street Superintendent form shall be signed by the Mayor or Village Board Chairperson and shall include a copy of a resolution of the governing body authorizing the signing of the Year-End Certification of City Street Superintendent form by the Mayor or Village Board Chairperson.

Be it resolved that the Mayor of Gibbon is hereby authorized to sign the attached Year-End Certification of City Street Superintendent form.
