The Gibbon City Council, Buffalo County, Nebraska met in open public session at 7:00 p.m. at City Hall on Tuesday, February 22, 2022. Notice of the meeting was given in The Shelton Clipper on February 17, 2022 and by posting at Gibbon City Hall, Gibbon Post Office and Gibbon Exchange Bank.

Mayor Deb VanMatre called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. The Open Meetings Notice is posted on the north wall of the Council Chambers. The City of Gibbon abides by the Open Meetings Act in conducting business.

Presentations and Proclamations:

Buffalo County Sheriff Department—Captain Anderson: Captain Anderson reported January activities for the department. Christopher Jarmin will be done with his training and graduate at the end of April. There was nothing significant to report for January. The CSO officer has been working with the city on ordinance violations.

Mayor Report—Deb VanMatre: Mayor VanMatre informed the Council that the March 19 Strategic Planning meeting has been cancelled and will be rescheduled for a later date. There are several board appointments and reappointments on the agenda, which will fill the active boards at this time.

City Attorney Report—Barry Hemmerling: Mr. Hemmerling reported there are several ordinance updates on the agenda. These reflect legislative updates, and there will be more next month. Code books will be updated as well.

City Administrator—Larry Homan: Mr. Homan reported there are two staff vacancies, which are for the cemetery sexton and the recreation department coordinator. Keno receipts for January were \$3,158.94 compared to \$5,909.38 for last year. Sales Tax receipts for were \$36,107.50, up from \$14,587.59 for last year. There were four building permits this month. Mr. Homan report the Civic and Community Center Finance Fund (CCCFF) grant application for \$375,000 along with business letters of support and recent survey results had been submitted. Mr. Homan is continuing to seek additional funding options for the Fire Hall/City Hall/ Community Room project. The coordination for wood reclamation on the Jarmin house will be taken care of by end of the month. The project manager with the State Department of Roads stated sidewalk and some shoulder work will need to be completed in the spring. There were two revised building permits submitted for the BC Estates subdivision. The golf course will open for the season on April 1st. Matt has been working with Deb Stroh at the school to develop an informative video multi-media presentation of Gibbon's water and waste water operations. Spring clean-up date is scheduled for May 7th. We have reached out to former seasonal employees to gauge interest for the summer. Mr. Homan let the council know we've received the assessment of damages from the December 15, 2021 wind storm, which included damage to trees, fencing at Rosen Park, Davis Park, Legion Park, power lines in Davis Park, the flag pole at city hall and some holiday decorations. Mr. Homan met with staff for internal strategic planning and training sessions to discuss and prepare for 1-3 years out.

City Treasurer Report—Susan Tonniges: Susan reported on the financials. The city is one third of the way into the fiscal year and totals show we are on track. She also went over the sales tax reports.

Piper Sandler & Company—Brad Slaughter: Mr. Slaughter went over the information on the General Obligation Municipal Building Bond Series 2022 in the amount of not to exceed \$465,000.

Proclamation—FBLA Week Proclamation: The Mayor formalized the proclamation previously signed.
