## MINUTE RECORD GIBBON CITY COUNCIL MONDAY, MARCH 12, 2018

The Gibbon City Council, Buffalo County, Nebraska met in an open public session at 7:00 p.m. at City Hall on Monday, March 12, 2018. The Mayor, Council Members, and the public were advised of the notice by publishing and posting. No additional items were added to the meeting during the twenty-four hours preceding the meeting.

Mayor Deb VanMatre called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. A notice of the Open Meetings Act is posted on the north wall of the Council Chambers. The City of Gibbon abides by the Open Meetings Act in conducting business.

Presentations and Proclamations:

Buffalo County Sheriff Department—Contract Law Enforcement: Captain Anderson and Sheriff Miller reviewed the activity of the department with the Mayor and Council Members. They said it was very good to see Barry, they had been thinking about him since his accident. Four people have passed away in the county from accidents. One person fell after being hit in the parking lot of the Pack. He hit his head and passed away in the hospital. No criminal charges have been filed concerning the accident. The other deaths were weather related. They will be setting up the speed trailer down by the school, and on 7<sup>th</sup> Street. They maintain a good relationship with the school. They will be holding a training session with the school staff, EMS, and BCSD concerning the protocol if such an incident happens as happened in Florida. They have a new CSO, his name is Conner Beard. They are conducting more traffic control south of town with the crane watchers in the area. The speed limit on: Highway 30 was raised to 65 mph. They are working on a new program which will enable access to accident reports online, links to the sex offender registry, pictures of people in jail, and outstanding warrants. This will be available through the Sheriff's website and the Kearney Police website, and may be added as a link on the City's website.

WWTP Report and Water Report: Matt Smallcomb reviewed the report. There was one permit violation in February. We had problems with the decant valve on SBR #2. We found that we had some bad wiring to that actuator. The flow meter and flume design have been approved and sent in to be constructed. The sampler ran for 30 days, and we received good data from the temporary sampler. Blower #4 failed and we switched to blower #2. We will be meeting with Olsson Associates tomorrow to discuss several issues at the plant such as the placement of the manhole.

Water Report: We changed out the electrical box and wiring on 7th Street lift station. We had a water leak at 501 2<sup>nd</sup> Street. The resident at 312 Lawn Avenue has had problems with low water pressure. We replaced the curb stop, but it didn't help. We will have to re-tap the Corp on the main. The pumps at the swimming pool were exercised. We completed 11 locates.

Mayor Report—Deb VanMatre: We have an Ordinance on the agenda to change the hours for the sale of alcohol; tonight we will have the 2<sup>nd</sup> and final reading. The Resolution on the agenda refers to a special meeting being called by the participating members of the League Association of Risk Management. There are issues with LARM and their board, as they have not been following the terms

of the interlocal agreement signed with all their members, or their bylaws, such as neglecting to hold elections for board members, and attempting to change their bylaws and organizational structure without the approval of their membership.

City Attorney Report—Barry Hemmerling: Nothing

City Administrator Report—Chris Rector: We sent out several letters to residents concerning unlicensed vehicles. We will also be sending out more letters concerning nuisance properties around town. We have several properties that are run down, which I will be discussing with Barry about how to proceed. April 28<sup>th</sup> will be our spring cleanup day.

City Treasurers Report—Tonniges & Associates—Ashley: Ashley was unable to attend the meeting.
