4. Presentations and Proclamations

a. Buffalo County Sheriff's Department--Contract Law Enforcement

Minutes:

Buffalo County Sheriff's Department—Sergeant Joe Andersen: Sergeant Andersen reviewed the monthly reports. Nothing significant other than the train derailment. Council member Kraenow asked about U-turns in the downtown area and requested extra patrol around 4th Street as juveniles were riding a minibike and expressed his concern for their safety

b. Mayor Report--Deb VanMatre

Minutes:

Mayor Report—Deb VanMatre: Mayor VanMatre reported the city had been in contact with Union Pacific regarding the derailment and we are watching for any further damage to streets with the heavy equipment they are using for the cleanup. The Environmental Protection Agency Administrative Order for Compliance on Consent has been signed. The former city hall building purchase was complete with Faith United Church purchasing it for their food pantry. We may come to the council in the near future regarding the potential sale of the Scoular "Fox" building. Mayor VanMatre informed the council the League of Nebraska Municipalities Executive Board will be touring Gibbon and holding a meeting at City Hall on July 26th. She indicated the city budget work session will be held on August 26th at 5:00 p.m. The September budget hearings and meeting dates are yet to be determined. A change of date for the November meeting will be an action item.

c. City Administrator Report--Matt Smallcomb

Minutes:

City Administrator Report—Matthew Smallcomb: Mr. Smallcomb provided the monthly operations report. He informed the council the Kearney Harmon Park pool had been vandalized and many Kearney patrons were coming to Gibbon. He has spoken to Kearney, and we will possibly be open longer hours and utilize some of their lifeguards while their pool gets repaired. Mr. Smallcomb gave an update on Nebraska Public Power District's annual report. There will be an increase of 2% in power costs. He informed the council that Gibbon Pack is moving forward on their construction and will be paving Beatty Street. The Pack will be relocating the truck entrance to the west side of their property, which should alleviate stopped turning traffic on Highway 30. There will be information on the street closure during the construction in the next newsletter. With the increase in food and vendor sales from trucks, Councilman Kraenow had asked about regulations regarding this type of business. Mr. Smallcomb provided examples of ordinances to the council. The State of Nebraska has a sight for food vendors with information on requirements for communities that have ordinances. Councilman Stall asked the status of the gas burner building and receiving the parts from David City. The engineers are currently working on the project and as soon as that is in place we are ready to proceed.

Economic Development Council of Buffalo County—Trevor Lee: Mr. Lee updated the council on the Nebraska Department of Economic Development Industrial Site Evaluation and the DED and Gibbon's 141-acre site and the pilot program. He reviewed the Economic Development Council of Buffalo County's annual investor report. The Development Council is building a new facility and welcome center near Kearney's new sports complex, along with the Kearney Chamber and Kearney Visitors Bureau. The EDCBC has helped in several projects within Gibbon and is currently working on others. Mr. Lee requested the council consider an increase in the city's funding for the year 2024-2025 for operations.

Board of Directors of LARM has adopted a plan to provide contribution credits in consideration of certain agreements by members of LARM as provided in the attached letter.
